INFORMATION - SKY AND ANOM CASES WITH CONFIRMED INDICTMENTS

Dalibor Railić at all (*8 persons*) - action "Transporter"; Indictment filed December 6, 2022.

Introduction

A total of eight persons were charged with organised crime related to several serious criminal offences, including the murder of the Head of the Prijedor Criminal Investigation Department, Radenko Bašić. The case included evidence from the Sky and Anom applications and covered crimes committed in the period from 2020 to 2022.

Indictment

The accused, through prior agreements on encrypted apps, engaged in the smuggling, transportation, and distribution of Cocaine and Marijuana on multiple occasions within Bosnia and Herzegovina and internationally. Additionally, Railić, one of the accused, is charged with using unlawfully obtained funds from narco-crimes to acquire properties, real estate, and luxury vehicles. The court has been requested to freeze their assets, and further proceedings will aim to seize all illegally acquired possessions. Furthermore, Railić, Miljatović, and Repajić are accused of organising a group to murder the Head of the Prijedor Criminal Investigation Department, Radenko Bašić, disrupting security in Prijedor and Bosnia and Herzegovina.

Accused criminal offences

Organised Crime (Article 250 of the Criminal Code of BiH), Illicit Trafficking in Narcotic Drugs (Article 195 of the Criminal Code of BiH), Money Laundering (Article 209) and Aggravated Murder (Article 125 of the Criminal Code of RS).

Investigation

The prosecution aims to substantiate the indictment's claims using 76 witnesses, 4 diverse expert witnesses, and numerous pieces of evidence, including data from Sky and Anom applications obtained through mutual legal assistance and international collaboration with EU and global partner institutions.

Court proceedings
