

INFORMATION - SKY AND ANOM CASES WITH CONFIRMED INDICTMENTS

Dragan Pejović zvani „Bosanac“ at all. (14 persons) - action “Staza”;

Indictment filed: June 14, 2023.

Introduction

Indictment issued in the Sky case, code-named "Staza," against 14 accused persons, who mainly operated in the area of Trebinje, Foča, Istočno Sarajevo, and Gradiška. They were connected to members of organised criminal groups operating in neighbouring countries, posing a threat to regional security.

Indictment

Dragan Pejović, is accused of leading an organised crime group between 2020 and 2022, involving members such as Milijan Mijović, Anđelko Milosevic, Aleksa Malis, and others. The group specialised in unauthorised trafficking of narcotics, particularly marijuana, using encrypted communication through the SKY ECC application. They orchestrated the smuggling of large quantities of drugs across borders, engaging in the purchase, transportation, and distribution of narcotics. Vladan Kovacevic, an employee of the Border Police of Bosnia and Herzegovina, is accused of being involved in transporting narcotics.

Accused criminal offences

INFORMATION - SKY AND ANOM CASES WITH CONFIRMED INDICTMENTS

Organised Crime (Article 250 of the Criminal Code of BiH), in connection with the criminal offence of Unauthorised Trafficking in Narcotics (Article 195 of the Criminal Code of BiH).

Investigation

The prosecution will prove the allegations of the indictment by calling a large number of witnesses and expert experts, as well as by submitting around 200 pieces of evidence.

Court proceedings

Indictment confirmed: June 28, 2023.

Guilty plea: On September 1, 2023, Dragan Pejović, Miljan Mijović, Anđelko Milošević, Aleksa Mališ, Mišo Miljanić, Dušan Mićanović, Nemanja Prnjat, Milan Mićanović, Vladan Kovačević, Bojan Čalasan, Milan Rašević and Dražen Salamadia pleaded not guilty.

The accused Goran Novčić and Miloš Kovačević did not attend the hearing and in relation to these defendants, a new hearing will be scheduled.

Verdict

On November 16, 2023 three defendants Miljan Mijović, Mišo Miljanić and Milan Rašević signed a guilty plea agreement and the Court of BiH imposed following sentences on the accused:

Miljan Mijović was sentenced to three years in prison.

Mišo Miljanić was sentenced to one year and six months in prison.

Milan Rašević was sentenced to one year in prison.

On December 12, 2023, six defendants Dragan Pejović, Anđelko Milošević, Aleksa Mališ, Dušan Mićanović, Nemanja Prnjat, and Dražen Salamadia reached an agreement on the admission of guilt with the Prosecutor's Office and the Court of BiH imposed following sentences on the accused:

Dragan Pejović was sentenced to five years in prison with confiscation of illegal property valued at 35,000 BAM, including a BMW.

Anđelko Milošević was sentenced to one year and six months in prison with confiscation of illegal property valued at 1000 BAM.

Aleksa Mališ was sentenced to one year in prison with confiscation of illegal property valued at 1000 BAM.

Dušan Mićanović was sentenced to one year in prison with confiscation of illegal property valued at 1000 BAM.

Nemanja Prnjat was sentenced to one year in prison with confiscation of illegal property valued at 500 BAM.

Dražen Salamadia was sentenced to one year in prison with confiscation of illegal property valued at 1400 BAM.

INFORMATION - SKY AND ANOM CASES WITH CONFIRMED INDICTMENTS

On December 26, 2023 three defendants Milan Mićanović, Vladan Kovačević and Bojan Čalasan reached a guilty plea agreement and the Court of BiH imposed following sentences on the accused:

Milan Mićanović was sentenced to one year and four months in prison.

Vladan Kovačević was sentenced to three years and six months in prison.

Bojan Čalasan was sentenced to one year in prison.

In the SKY case code-named 'Staza' /'Path'/, twelve (12) accused persons have signed Plea Agreements, including the group's organiser. Prison sentences ranging from one (1) to five (5) years in prison were proposed and imposed for these accused persons. In this way, this is the first case with evidence from SKY and Anom applications in the Western Balkans region in which almost the entire organised crime group signed Plea Agreements admitting their guilt, after which the judgments against them became final and binding.

Case status: Case closed for 12 accused. Case is still open for Goran Novčić and Miloš Kovačević.
