## GORDANA BOSILJČIĆ – PROSECUTOR OF THE PROSECUTOR'S OFFICE OF BOSNIA AND HERZEGOVINA

Gordana Bosiljčić was born in Sarajevo, Bosnia and Herzegovina, in 1960. After completing her primary and classic-programme secondary school, she graduated from Sarajevo University Faculty of Law in 1983 and passed the bar exam in January 1985. She completed postgraduate studies at the same faculty in 1987 and was conferred the title of Master of Law Sciences at the Sarajevo Faculty of Law.

She has been working in judicial institutions since 1985, first as an expert associate at Sarajevo Municipal Court II in the period from 01.03.195 to 30.12.1985, then as Deputy Municipal Public Prosecutor in the Municipal Public Prosecutor's Office I in Sarajevo, then as an expert associate in the Basic Public Prosecutor's Office in Ilidža from 14.021994 to 23.11.1994 and, from 1994, as a Deputy Prosecutor at Ilidža Basic Public Prosecutor's Office.

In the period between 05.09.1997 and 15.09.2002 she worked in the Economy Office of the UN Mission to Bosnia and Herzegovina and then, from 15.09.2002, as a Deputy Disciplinary Prosecutor at the Office of the High Representative (OHR) and in the Independent Judicial Commission, as well as in the OHR Office of Disciplinary Prosecutor.

For some time she worked as a legal advisor at the OHR for international judges of the Court of Bosnia and Herzegovina.

She was appointed prosecutor of the Prosecutor's Office of Bosnia and Herzegovina on 1 March 2007. She works in Department III of the Prosecutor's Office of Bosnia and Herzegovina.

She attended many professional seminars and trainings during her career and the most important ones of them are as follows:

- A seminar organised by the Republic Secretariat for Legislation and Administration of the Socialist Republic of Bosnia and Herzegovina titled '*Forms of Attacks on Public Property*', Tuzla, July 1987;
- A seminar organised by the Constitutional Court of Bosnia and Herzegovina titled *Notion and Understanding of the Constitution of Bosnia and Herzegovina after Dayton*', Mostar, 17 and 18 May 1999;

- A seminar organised by the Council of Europe titled '*Position of National Minorities in the World with a Focus on the Situation in Bosnia and Herzegovina*', Sarajevo, October 2001
- A seminar organised by the UN Mission to Bosnia and Herzegovina (UNMIBH) titled 'Special Needs of Women and Children During and After the Conflict – Situation on the Balkans', Sarajevo, 22 November 2001.

Prosecutor Bosiljčić attended numerous specialist trainings abroad, including those organised in Portugal, USA, Italy, Romania, Austria and Germany. She actively speaks German and English. She is an author of several professional papers in the field of fight against terrorism, which were published in Bosnia and Herzegovina and abroad.
