Biography

HAJRUDIN MUJANOVIĆ – PROSECUTOR OF THE PROSECUTOR’S OFFICE OF BOSNIA AND HERZEGOVINA

Hajrudin Mujanović was born Kikači, Kalesija Municipality, Bosnia and Herzegovina, on 25 May 1955. He finished Secondary Administrative School - EUŠC in Tuzla and after that graduated from Faculty of Law of the University “Džemal Bijedić” in Mostar in 1981. He passed his bar exam in 1988 in the Republic Secretariat for Justice and Administration of the Republic of Serbia in Belgrade.

He began his professional career by taking up employment with the RO “KARTONAŽA” (Work Organisation “Pasteboard Boxes”), Tuzla, on 9 December 1982 where he worked as Head of Legal and General Affairs Division until 31 October 1983. After that and until 10 August 1987, he worked as Head of Legal and Administrative Services at SOUR “UMEL” RO “MPI” – metal processing industry in Živinice.

Until 31 August 1990, he served as Head of Legal Department at *Trgovinsko preduzeće na veliko i malo* (wholesale and retail company) “TEHNOPROMET” p.o. (work organisation) Tuzla.

He began his judicial career by working as a permanent judge at Tuzla Basic Court for Associated Labour in the period from 01.09.1990 to 30.06.1992, after which he worked under work obligation as a market inspector for the Tuzla municipality.

In the period from 16 February 1993 to 1 February 1996 he served as a judge at Tuzla Higher Misdemeanour Court and in the period between 2 February 1996 and 31 May 2000 he served as a lawyer at Tuzla Regional Bar Association.

After that, on 1 June 2000, he was appointed Deputy Prosecutor of Tuzla Cantonal Prosecutor’s Office, where he served until 2003.

In the period from 2003 to 31 December 2015, he served as Prosecutor of the Cantonal Prosecutor’s Office in the Tuzla Canton and Head of Department for Blood, Sexual Assaults and Drugs of that Prosecutor’s Office.

He took office with the Prosecutor’s Office of Bosnia and Herzegovina as a prosecutor on 1 January 2016.

He is a co-author of '*Priručnik za praktičnu primjenu Zakona o prekršajima sa komentarom, obrascima, izmjenama i dopunama i registrom*' (Manual for Practical Application of the Law on Misdemeanours with Comments, Forms, Amendments and Supplements and Register) published by the DD (Joint-Stock Company) Radnički univerzitet – Printing Office Lukavac in 1995.

He attended a number of seminars among which also a seminar on terrorism in 2015.
